## **Privacy Policies**

The Laura Ingalls Wilder Children's Literature Festival is a rain or shine event. However, programming and schedules are subject to change, weather permitting. General admission to the Laura Ingalls Wilder Children's Literature Festival in Marshfield, MO is free. However, when touring the Laura Ingalls Wilder Home and Museum in Mansfield, MO an all-day Adult Admission will be \$7.00 for parents, \$4.00 for educators, \$3.00 for children and ages 5 and under are admitted free. Open-house style, kid-friendly tours, will be conducted both days of the Literature Festival.

## **FARMHOUSE AND ROCK HOUSE TOURS**

The festival is free to attend; however, visitors will need to purchase a ticket in order to tour the Farmhouse, Rock House and Museum Exhibits. Tickets are available for purchase onsite in the main lobby only days of the event. Visit the home page of our website for information on pricing. All ticket sales are final. No refunds or exchanges. Tickets are not for resale and are non-transferable. Due to the Americans with Disabilities Act [ADA] compliance, only the lower levels of both homes are available for touring, and there is limited access for extremely large crowds in the farmhouse rooms, patience may be required to wait in a line due to overcrowding. The festival will not offer compensation based on inclement weather and in the case of extreme weather conditions.

## **ROCKY RIDGE FARM RESTRICTIONS**

Tripping hazards are unavoidable on the Farmhouse and Rock House lawn and by the outbuildings, the highest degree of care is expected of all visitors.

- Proper footwear must be worn by all visitors (rubber sole shoes, or sneakers).
- Visitors may not sit on the homes furnishings or built in benches.
- Smoking is not permitted. Alcoholic beverages, food (including chewing gum and candy) and beverages are strictly prohibited and not permitted in the houses.
- Visitors may not run, jump or climb the small stairway in the home.
- No coolers or bags more than 14 inches long are permitted in the Historic Homes. No glass containers, cans or alcoholic beverages, pets [unless a service animal], bicycles, skateboards, roller skates, roller blades or weapons.
- No photographs are to be taken in the Historic Home, Rock House, or Museum Exhibition area.
