### Backyard Competition 2014

This is the first year for our Backyard competition! We hope this is a fun and educational experience for noncompetitive BBQ cooking teams. Team up or face off with your friends and neighbors in a fun event and help raise some money for Rock'n Freedom!

Teams will check in either Friday (Before 5:00pm) or Saturday (Before 7:00am).

Meats: Teams will do 2 turn-ins to judges Ribs & Pork Butts. Teams must cook 2 pork butts what you don't turn-in will be used for People's tasting.

Meat inspections—We will inspect your meat at your request Once your meat is inspected it can't leave your site.

You will turn in enough for 6 judges. Remember to cut all the way through your meat. Judges can't pull meat apart. So if one judge gets 2 ribs because they were not cut apart you will have a judge without meat. You can put more than 6 ribs in your clamshell.

We will give you 2 clamshells when we check in your meat. One for pork and one for ribs.

Garnishment—you can use green lettuce or parsley. No red tip lettuce or keel.

You will turn in Ribs @ 6:00pm & Pork @ 6:30 at the white tent. You have 5 mins before and 5 mins after. If you are not in line by 5 mins after you are disqualified in that category. You will be judged on Taste, Tenderness and Texture.

People's Tasting 7:30: We will give you 100 chicken wings for people's tasting and you will hand out your remaining pork. Each person gets 2 votes and the team with the most votes wins!
